#### 5.3.1 Student council is active and plays a proactive role in the institutional Functioning

TEI is very much aware about the significant role of student council in college development. This TEI provide importance to the active, functional, innovative involvement of student council.

In Nirmala Memorial Foundation College of Education, Kandivali East, student council is formed as a student representative body that acts as a liaison between the staff and students. They are instrumental in ensuring smooth implementation of co-curricular activities by mobilizing students to participate, plan and execute the various range of activities conducted by the college; both curricular and co-curricular. Under the guidance of the Principal and the faculty in-charge, student council is responsible for conducting a variety of events.

Its main objectives are to maintain discipline, provide mechanisms to address grievances, conduct various programs, develop team-spirit, leadership skills and cooperative learning among student teachers. The various activities conducted by the Students' Council include conducting regular meetings, giving instructions in the classes, conducting academic, sports and cultural activities smoothly and to address the grievances of students to tutorial group teachers and Principal.

The student council works closely with both the staff as well as the students. They are an important link in the communication and transmission information between the institution and the students. The purpose of the Student Council (SC) is to serve as the effective communication medium between the administration and students. Even though there is a fair chance to every student to communicate at any time with the administrative officials, Student Council acts as the interactive body facilitating primary level of communication.

**Sports Committee:** The Sports committee is responsible for organizing the annual sports day event in TEI. Apart from this, the sports committee also organizes small indoor/ online events for the purpose of promoting sports and sportsman spirit among the students.

**Cultural Committee:** The cultural committee oversees the coordination of students to ensure maximum participation of student-teachers to put up good quality cultural programmes to be showcased at various inter and intra collegiate platforms.

**Discipline Committee:** The discipline committee is responsible for the discipline among student-teachers.

**Community Social activity Committee:** The community social activity committee oversees the coordination and participation of student-teachers in various community and social activities to encourage social discipline and social responsibility among the students.

**Library Committee:** The Library Committee is responsible for the various library facilities provided to the student- teachers.

**Student Welfare Committee:** The Committee focuses on all round development of the students by addressing their needs, providing counselling to slow learners, and fostering positive psycho-personal motivation and guidance to them.

Ref: Formation of University Students' Council, University Students' Council and Students' Council of each institutions conducted colleges and affiliated colleges under section 40 of the Maharashtra Universities Act,1994 and the Maharashtra Universities (Amendment)Bill 2000 C.L.A.Bill No.XLIV of 2000,This Act may be called the Maharashtra Universities (Amendment & Continuance)Act, 2000 (Mah. Ord.IX of 2000)

WHEREAS the Maharashtra Legislature has passed the Maharashtra Universities Act, 1994 with a view to provide among others for representation of students in various bodies of the University to take measures for curbing or for eradicating undesirable non-academic influence detrimental to maintenance of discipline and standards of education and academic excellence in the University and to provide for matter connected with or incidental thereto in the Non-Agricultural Universities in the State which was assented to by the Governor of Maharashtra on 21<sup>st</sup> July,1994, and same came into force with effect from 22<sup>nd</sup> July,1994;

#### AND

WHEREAS Section 40(1) provides that there shall be a University Students' Council as specified in sub-section (4) a University Departments Students' Council for post-graduate Departments of the University and a Students' Council for each conducted colleges of institutions of the University of each affiliated colleges, to look after the welfare of the students and to promote and co-ordinate the extracurricular activities of different students' associations for better corporate life, which shall not engage in political activities.

WHEREAS the matter of formation of the University Students' Council, University Departments Students' Council and Students' Council for each institutions, conducted colleges of affiliated colleges under the provision of section 40 of the Maharashtra Act 1994 has now become expedient in view of section 114(1) of the aforesaid Act;

#### AND

WHEREAS Statutes 169 to 174 relating to the Students' Council made under Section 34 of the Mumbai Universities Act, 1974 and statutes174A to 174N Relating to rules of procedure and conduct of business to be followed at the meeting of the Students' Council and the Students' Executive Union made under Section 34(4) of the Mumbai University Act,1974 are inconsistent with the provision containing in the Maharashtra Universities Act,1994.

#### AND

WHEREAS Section 27(1) of Maharashtra Universities Act, 1994 provides that the Management Council shall be the Principal executive authority to formulate statutes and forward the same to the Senate for approval and make Ordinances to administer the affairs of the University and shall carry out all such duties which are not specifically assigned to any other authorities;

#### AND

WHEREAS Section 114(1) of the Maharashtra Universities Act, 1994 provides that every authority of an existing University shall as soon as, practicable, but within a period of six months from the date of commencement of this Act, be reconstituted in accordance with the provision of this Act. Every such authority shall be deemed to be reconstituted with effect from each date as the Vice-Chancellor may, from time to time specify by notification;

#### AND

WHEREAS Section 52 of the Maharashtra Universities Act,1994, provides that manner in which the statutes are made, amended or repealed but it is difficult to follow the said procedure laid down in that behalf within a short period of time;

AND

WHEREAS sub-section (8) of section 14 of the Maharashtra Universities Act,1994, provides that where any matter is required to be regulated by the statutes, Ordinance of regulation, but no statutes, ordinance or regulation are made in that behalf the Vice-Chancellor may, for the time being regulate the matter by issuing such directions as he thinks necessary and shall at the earliest opportunity thereafter, place them before the Management Council or other authority or body concerned approval;

#### AND

WHEREAS I DR.VIJAY KHOLE, VICE-CHANCELLOR of the University of Mumbai, in exercise of the powers conferred upon me under section 14(8) of the Maharashtra Universities Act,1994 hereby direct that the following shall be the procedure for formation and other relevant aspects of the University Students' Council under section 40(4)(a) of the Act, and the University Department Students' Council as also the Students' Council for each institution, conducted colleges and affiliated colleges under section 40(2)(a) and (b) of the Act, respectively.

(1) that the formation of Students' Council for the University Department as also for each conducted colleges /institutions, and for each college affiliated to the University of Mumbai shall be in accordance with the provision of section 40(2)(a) and (b) respectively.

(2)That the name of the student from each University Departments who is willing to be a member of the University Departments Students' Council under Section 40(2)(a)(v) of the Act, and who has shown academic merit by securing the highest number of marks at the preceding degree examination and is engaged in full time studies shall be forwarded in the prescribed form by the respective Director/Heads of the University Department alongwith a name of one deserving Lady student who is willing to be a member of the University Department Students' Council under section 40(2)(vi) under section 40(2)(a) (vi) to the Director of Students' Welfare on or before the date to be fixed by the Vice-Chancellor and communicated by the Director of Students' Welfare on the University Departments Students Council as specified under section 40(2)(vi) of the Maharashtra Universities Act, 1994 by the Vice-Chancellor and the Pro-Vice Chancellor respectively.

(3) that the respective Students' Council as mentioned of Section 40(2)(a) and (b) of the Maharashtra Universities Act,1994 shall be formed by the President and the Chairman respectively as the case may be, on a date to be fixed by the Vice-Chancellor and communicated by the Director of Students' Welfare for the academic year, after having obtained the consent of the concerned students to be nominated on the respective Students' Council.

(4)that the election of Secretary of each of the respective Students' Council as mentioned under Section 40(2)(a) and(b) of the Maharashtra Universities Act,1994 shall take place on the seventh day after the formation of respective Students' Council and if the seventh day is a holiday then on the next working day after the seventh day.

(5)that the name of duly elected Secretaries of the respective students' council as mentioned under section 40(2)(a) and(b) of the Maharashtra Universities Act,1994 shall be communicated in the prescribed form by the respective Chairman of the Students' Council as mentioned under the said section only if the said secretaries are willing to be a member of the University Students' Council, further specified under section 40(4)(a), if nominated by the Vice-Chancellor. These names shall be sent to the Director of Students' Welfare immediately after the election so as to reach the Director's Office not later than 10 days from the date of election and if the tenth day is a holiday then on the next working day after the tenth day;

(6)that there shall be a selection committee comprising of the following members viz.

a The Pro-Vice-Chancellor

Chairman

- b Two Deans of faculties nominated by the Management Council
- c Commanding Officer of either Group 'A' & 'B' NCC Of a person having adequate knowledge of NCC, such as a teacher who is also a part-time Officer of senior division NCC nominated by the Management Council.
- d Director of Adult & Continuing Education or NSS Coordinator or a person having adequate experience in the relevant field nominated by the Management Council.
- e The Director of Sports or a person having adequate knowledge in sports nominated by the Management Council.
- f Cultural Coordinator of the University or a person having adequate knowledge in the performing Arts/Fine Arts, nominated by the Management Council.
- g The Deputy Registrar, Backward Class Cell of the University or a person belonging to SC/ST or O.B.C. nominated by the Management Council.

h One Lady Member nominated by the Management Council and in his absence, such other officer of the University nominated by the Vice-Chancellor (Member-Secretary)

The Committee shall meet within a week after receiving the communication forms mentioned at Sr. No. (5) above on a date, time and place fixed for the purpose of scrutinizing the aforesaid communication forms and for analyzing the information contained therein in the light of the performance in academic NCC/NSS /Adult Education Programme /other literacy programme, sports, cultural Activities and such other extra-curricular activities wherein following shall be the minimum eligibility criteria for considering the performance of the students in the activities listed below :

- a. <u>SPORTS:</u> A student must have participated at least once in either Inter-Collegiate or Inter-University Tournament.
- b. <u>NATIONAL SERVICE SCHEME/ADULT EDUCATION/OTHER</u> <u>LITERACY PROGRAMME OF THE UNIVERSITY</u>: A Student must have been enrolled and participated in the National Service Scheme programme by the college/University and completed prescribed hours work under the scheme <u>OR</u> a student must have been enrolled in an adult and continuing education and extension work project or any other literacy programme of the University, such as MPFL and must have completed the prescribed work previously in the academic year;
- c. <u>NATIONAL CADET CORPS</u>: A student must have been enrolled in the National Cadet Corps and attended at least 75 percent of the Parade and One camp organized by the NCC authority.
- d. <u>CULTURAL ACTIVITIES</u> A student must have participated in the Inter-Collegiate Competitions organized by the University in Dramatics, Elocution, Group Dance, Music, Painting etc or must have represented the University at any other competitions.

The aforesaid committee shall select not more than 15 students in various Categories and indicated below, in accordance with section 40(4)(a) of the Act, from amongst the Secretaries and respective Students' Council mentioned under section 40(2)(a)(b) of the Act, whose name are duly communicated to the Director of Students'Welfare as mentioned at Sr.No.(5) above to be recommended to the Vice-Chancellor for considering the same for nominating students on the University Students' Council mentioned under section 40(4)(a) of the Maharashtra Universities Act, 1994.

- (i) One Student belonging to Scheduled Caste;
- (ii) One student belonging to Scheduled Tribes;
- (ii.(a) One student belonging to Denotified Tribes
- (ii.(b) One student belonging to Nomadic Tribes;
- (iii) One student belonging to other Backward Class;
- (iv) One Woman student;
- (v) One student from among the colleges in the District of Sindhudurg;

- (vi) One student from among the colleges in the District of Ratnagiri;
- (vii) One student from among the colleges in the
- (viii) District of Raigad;
  - Two students from among the colleges in the District of Thane;
- (ix) Two students from among the colleges in the District of Suburban Mumbai;
- (x) Two students from among the colleges in the District of the city of Mumbai.

(7)that the Vice-Chancellor may request the Selection Committee mentioned above at Sr.No. (6) THEREAFTER to recommend a few more names if he deems it necessary and expedient in which case another meeting of the aforesaid Selection Committee shall be convened to select the required number of additional students from amongst the Secretaries of the Students' Council mentioned under section 40(2)(a) and (b) to be recommended to the Vice-Chancellor for reconsideration.

(8)that the University Students' Council shall be formed thereafter on a date fixed by the Management Council of the University for which the Vice-Chancellor shall nominate not more than 15 students from amongst the names suggested by the Selection Committee as mentioned above at Sr.No.(6) and (7) in accordance with section 40(4) (a) of the Act.

(9)that the students members of the University Students' Council so formed under the provisions of section 40(4)(a) of the Act, shall elect its own President and Secretary from amongst its student members after 21 clear days counted from the day of the formation of the University Students' Council under the provision of section 40(4)(b) of the Act, and if it is a holiday then on the next working day at its first meeting which shall be convened by the Director of Students' Welfare in consultation with the Vice-Chancellor;

(10)that the election, whenever conducted shall be held in accordance with the statutes 353 to 356,361,365,366,368 to 373,378 to 393 and that the Principal or the Director of Students'Welfare as the case may be, shall act as the election Officer for the concerned elections, whenever conducted.

(11)that meeting of the University Students' Council formed under the provisions of the section 40(4) and the University Departments Students' Council formed under the provisions of section 40(2)(a) of the Act, shall be held on the University premises, unless the Vice-Chancellor otherwise directs while meeting of the Students' Council for each institution conducted colleges and affiliated colleges, unless the Principal otherwise direct and that one third of the members of the students' council formed under the provisions of section 40(2)(a) and provisions of section 40(4)(a) of the Act, shall constitute the quorum for meeting of the respective students council in accordance with provisions of section 40(7) of the Act, when before the commencement of the meeting the notice of the attendance at the meeting shall be taken and if there is no quorum the meeting shall forthwith be adjourned. The adjourned meeting shall be held on the same day and at the same place after the expiry of half and hour from the hour notified for the commencement of the original meeting. No quorum shall be required at such adjourned meeting.

All questions shall be decided by a majority of votes of the members present at the meeting by show of hands. In the case of an equality of votes, the person presiding over the meeting shall have second casting votes.

(12)that the Secretary of the respective Students' council formed under the provision of section 40(2)(a), section 40(2)(b) and section 40(4)(a) of the Act, shall issue notice of the meeting of the said Students' Council in consultation with the Vice-Chancellor or the Principal, as the case may be, and that such meeting shall be called at least once in every three months in accordance with the provisions of section 40(7) of the Act, wherein such proposals or matters as are connected with and are incidental to the welfare of the students which help in promoting and coordinating the extra-curricular activities of different students associations/societies for better corporate life shall be entertained and discussed at the meeting with the permission of the Vice-Chancellor or the Director of Students' Welfare or the Principal as the case may be;

(13)that the meeting of University Students' Council formed under the provision of section 40(4)(a) and (b) shall be presided over by the Vice-Chancellor and shall be attended by the Director of Students'Welfare. The Pro-Vice-Chancellor the Registrar and such other officer/s of the University shall also attend the meeting when their presence may be required at the meeting on the order of the Vice-Chancellor, in accordance with the provisions of section 40(4)(a) (c) of the Act. In the absence, of both the Vice-Chancellor and the President elected under the provisions of section 40(4)(b) of the Act. In the absence of the Vice-Chancellor, the President elected under the provisions of section 40(4)(b) of the Act, shall preside over the meeting of the University Students' Council formed under section 40(4)(b) of the Act, the members of the University Students' Council present at the meeting shall elect a person from amongst them to preside over the said meeting while the meeting of the University Department Students' Council formed under the provisions of section 40(2)(a) shall be presided over by the Vice-Chancellor or by the Director of Students'Welfare in the absence of the Vice -Chancellor or by a person from amongst the members of the University Departments Students' council nominated by the Vice-Chancellor for that purpose and that the meeting of the Students' Council for each institutions, conducted colleges and affiliated colleges formed under the provisions of section 40(2)(b) of the Act, shall be presided over by the concerned Principal or a person from amongst the member of such Students' Council formed under the provisions of section 40(2)(b) of the Act, nominated by the Principal for that purpose;

(14)The concerned Secretaries of the Students' Councils formed under the provisions of section 40(2)(a) 40(a)(b) and section 40(4)(a) of the Act, shall record and maintain the minutes of the meeting of the respective Students' council soon after the meeting of the University Students' Council formed under section 40(2)(a) of the Act is over, the concerned Secretary shall form the Draft Minutes for approval of the person who presided the said meeting through the Director of Students' Welfare. The Secretary of the Students' Council for each institution conducted colleges and affiliated colleges hall forward the

draft minutes for approval of the Principal of the college or the person who presided over the said meeting, if the Principal was absent for the said meeting. The approved minutes shall then be sent to the concerned members as the case may be, for their information and record.

(15)that the function of the Students' Council formed under the provisions of section 40(2)(a), section 40(2)(b) and section 40(4)(a) and (b) of the Act, with reference to section 41 of the Maharashtra Universities Act, 1994 shall be :

- (i) To organize, supervise and co-ordinate the activities of the different Students' Associations, Societies and such other organizations such as Dance and Music Society, Debate and Elocution Society, Dramatics Society, Film and Photography Society etc., formation and functioning of which will be as decided in the meeting of the respective Students' Council as per the requirement of the respective activities and as approved by the appropriate authorities/Officials/Officers.
- (ii) To recommend to the appropriate authorities/officials, officers, the financial allocation to be made for the activities to be undertaken under the relevant budgetary heads.
- (iii) To allocate funds for the different activities of the Students Associations, Societies and other organizations, as sanctioned by the appropriate authorities/officials/officers.
- (iv) To submit an annual report of its work, together with a statement of its accounts to the appropriate authorities/officials/Officers on or before the date to be fixed for the same time to time.
- (v) To make recommendations to the appropriate authorities Officials/officers in respect of any matter affecting the corporate life of welfare of the students.
- (vi) To make recommendation to the appropriate authorities Officials/Officers regarding the existing facilities for institutions and
- (vii) To make recommendation to the appropriate authorities/Officials /Officers for setting the genuine grievance of the students.

These directions come into force with immediate effect and shall remain in operation till such time as the statutes are made in these respects in accordance with the provision of the Maharashtra Universities Act,1994 and Maharashtra Universities (Amendment)Ordinance 2000(Mah.Ord.IX of 2000) pertaining to the formation of Students' Council assented to the Chancellor.

#### (ix) STUDENTS COUNCIL

(Under Section 34 of the Act)

**S. 169.** (1) For purposes of this Statute, 'class' means a body of students in a college or recognized institution, undergoing a course of instruction leading to a University examination in a Faculty.

(2) Each class shall elect one representative on the Electoral College. Such a representative shall hereinafter be called as 'Class Representative'

(3) Election for forming the Electoral College shall be held by ballot, on the basis of the principle of simple majority vote.

(4) The Vice-chancellor shall fix and announce a date for holding the election of Class Representatives which shall, in any case be not later than 45 days from the commencement of the academic year. The Principal of a College/Head of a Recognized Institution shall make the necessary arrangements for holding the elections on such notified date.

(5) The Electoral roll of a College/Recognized Institution shall consist of all the class representatives of that College/Institution. These class representatives, immediately on the seventh day after election of the class representatives held on the date notified under S.169 (4) and if it is a holiday, on the next working day after the seventh day, shall elect one from among themselves to be a member of the Students' Council to represent the College/Institution (hereinafter called the 'University Representatives') in a meetings to be convened by the Principal/Head of the Institutions.

(5A) A Notification regarding the election to the 'Class Representative' and the University representative' shall be sent to the College/Intuition simultaneously.

**S.170.** For the purpose of election of one student from each teaching Faculty of the University under Section 34(1)(iv) of the Act, for each teaching Faculty of the University, a separate electoral college consisting of one representative of each class in the University Departments covered by the Faculty in question shall be constituted.

\*The Vice-Chancellor may only in extra-ordinary extreme circumstances which have arisen in the prescribed limit of 45 days sand therefore it becomes impossible to hold the election, fix and announce the date beyond by the Prescribed limit for reasons to be record.

Where the University faculties enroll students and conduct classes at a place outside, Greater Bombay, such students in such faculties at such places outside Greater Bombay shall constitute a separate class at their respective places and their representatives shall be a part of the Electoral College, consisting of Class Representatives.

The Vice-Chancellor shall fix a date for holding the election of Class Representatives of the respective faculties, which shall in any case not be later than 45 days from the commencement of the Academic year. The Vice-Chancellor may, only in extra-ordinarily extreme circumstances, which have risen in the prescribed limit of 45 days and therefore it has become impossible to hold election, fix and announce the date beyond the prescribed limit for reasons to be recorded.

The Vice-chancellor, in consultation with the Director of Students' Welfare, shall appoint any of Heads of the departments within the respective faculties and the respective places, as the case may be, to conduct elections of the Class Representative within the faculty.

These Class Representatives for separate faculties immediately on the 14<sup>th</sup> day after the date of election of the Class Representatives, and if it is a holiday, on the next working day after the 14<sup>th</sup> day shall elect one from among themselves to be a member of the Students' Council, in a meeting to be convened by the Director of Students' Welfare. The result of the election shall notified within three (3) days from the date of election.

**S.171.** (1) The election of Students' Council shall be held by ballot and in accordance with the system of proportional representation by means of a single transferable vote in the manner laid down in Statutes 353 to 394.

- (2) If a student, by virtue of his being a student of more than one college /Institution/Department, is elected as a member on the Students' Council from more than one College/Institution/Department, he shall at his option, to be exercised within 24 hours of the declaration of the results of the last election, retain his membership of the Students' Council from only college/Institution/Department and relinquish his membership [from the other or others. In such a case, the person who is next in order in the College/Institution Department in respect of which the membership has been relinquished, shall ipsofacto be demmed to be elected on the Students' Council.
- (3) In case, a student is contesting the election from more than one college on the Students' Council, he shall inform the Principal, Head of the College/Institution/Department concerned and in the case of election of only such students, at the time of counting, a note shall be kept of the first three candidates in order of preference.
- (4) No student shall be eligible to be a member of the Student's Council, if he has completed 25 years of age on the date of the election. In case an elected student completes the age of 25 years during his term of office, he shall cease to be a member on the Council on the day he at6tains the age of 25 years. He shall also cease to be such member if he fails to appear or pass at the next University Examination for which he was enrolled when he because member. If such a vacancy occurs during the session, it shall not be filled-up.
- (5) The name of the University Representative duly elected shall be communicated by the Principal/Head of the Institution to the Director of Students' Welfare immediately after the election so as to reach the office of the Director of Students' Welfare not later than 10 days from the date of election.
- (6) A Notification regarding the election of the Chairman, the Secretary of the Students' Council and the Students' Executive Union shall be issued by the Director of Students' Welfare within seven days from the final date of received names of the University Representative.
- (7) The Notification regarding the date of election of the office bearers of the Students' Council and the Students' Executive Union shall be issued respective of the fact that the date of election falls in Diwali Vacation or any other vacation.

**S.172.** (a) The Vice-chancellor shall appoint one student from each Faculty on the Students' Council, under the provisions of Section 34(1)(v) of the Act, who has secured the highest percentage of marks in the aggregate of all the subjects prescribed at the preceding degree examination/s in the faculty concerned from amongst those engaged in full-time post graduate studies in a University Department and or affiliated, conducted, constituent or autonomous college or a recognized institution and who are not above 25 years of age. Provided that such a candidate must have passed the examination within the minimum period prescribed for the degree course from the date of passing the qualifying examination for admission to the course leading to he said degree.

- (b) The Vice-Chancellor shall nominate eight other members under Section 34)1)(vi), two from each of the four, activities, viz, (i) Sports, (ii) National Service Scheme, (iii) Nation Cadet Corps and (iv) Cultural Activities, on the recommendation of the appropriate authorities and/or the Director of Students' Welfare.
- (c) The Vice-Chancellor will nominate tow lady students.

**S.173.** In the first meeting of the Students' Council to be convened by the Directors of Students' Welfare, the student shall elect from amongst themselves the Chairman, the Secretary and Fourteen members of the Students' Executive Union under the provisions of Section 34(2)(iv) of the Act.

**S.174.** Fourteen members of the Council shall be elected on the Students' Executive union under the provisions of Section 34(2)(iv) of the Act, at the first meeting of the Council convened by the )President of the Students' Council during each academic year.

For such election, a notice of election shall be sent at least 21 clear days before the date of the election, to the student-members of the Council inviting nomination from amongst themselves as under :-

- (1) One member each to represent the activities mentioned below :-
  - (i) Sports
  - (ii) National Service Scheme
  - (iii) Nat6ional Cadet Corps
  - (iv) Cultural Activities.
- (2) One Lady Student
- (3) Nine others.

The election shall be held in the meeting of the Students' Council in the manner prescribed by Statues No.378-394.

For purposes of this Statute, members of the Council representing the four activities shall be those who have participated in one or more of the four activities mentioned in section 34(1)(vi) of the Act at least, in the manner given below :-

- (i) Sports : A student must have participated at least once in either Inter-collegiate or Inter-University Tournaments.
- (ii) A National Service Scheme: A student must have participated in the National Service Scheme programmes organized by the College or university and attended prescribed hours of works under the scheme.

(iii) National Cadet Corps : A student must have been enrolled in National Cadet Corps and attend3ed at least 75 percent of the parades and one camp organized by the N.C.C. authorities.

::4::

(iv) **Cultural Activities:** A student must have participated in the Inter-Collegiate competitions organized by the University in dramatics elocution, group dance music painting etc.

A student in order to become eligible for election under the four activities referred to above shall produce a certificate from the Principal/Head of the College or /Institution or Department.

### Rules and Procedure and Conduct of Business to be followed at the meetings of the Students' Council and the Students' Executive Union.

(Section 34(4) of the Act)

**S. 174A.** Meeting of the Students' Council and the Students' Executive Union shall be held on the University premises, unless the Vice-Chancellor otherwise directs.

**S. 174B.** One-third of the members of the Students' Council shall form a quorum for a meeting of the Council. All questions shall be decided by a majority of votes of the members present at the meeting of the Council by show of hand. In the case of an equality of votes, the Chairman of the meeting shall have second or casting vote.

**S. 174 C.** The meetings of the Students' Council shall be presided over by the Vice-Chancellor and in his absence by the Chairman of the Council. The Vice-Chancellor shall nominate a member of the Council to preside over the meeting of the Council in the absence of both the Vice-Chancellor and the Chairman of the Council.

**S. 174 D.** Before the commence of a meeting of the Students' Council, the Chairman of the meeting shall take notice of the attendance at the meeting and if there is no quorum, the meeting shall forth with be adjourned. The adjourned meeting shall be held on the same day and the same place at the expiry of half an hour from the hour notified for the commencement of the original meeting. No. quorum shall be required at such adjourned meeting of the Council.

**S. 174 E.** Such proposals or matters only as lie within the functions of the Students' Council specified under Clause (5) of Section 34 of the Act, and such other proposals or matters as are referred to them by any other authority or officer of the University shall be entertained and discussed at the meeting of the Council.

**S. 174 F.** The meeting of the Students' Executive Union shall be held at least twice a year and at other times when convened by the Chairman of the Union However, if felt necessary, a meeting of the Union may be convened by the Director of Students' Welfare' in consultation with the Vice-Chancellor.

**S. 174 G.** One-third of members of the Students' Executive Union shall form a quorum for a meeting of the Union. All questions shall be decided by a majority of votes of the members present at the meeting of the Union by show of hand. In the case of an equality of votes, the Chairman of the meeting shall have a second or casting vote.

**S. 174 H.** The meeting of the Students' Executive Union shall be presided over by the Chairman of the Union and, in his absence, by a member of the Union nominated by the Vice-Chancellor for the purpose.

S. 174 I.

**S. 174 J.** The Director of Students' Welfare shall issue notices of the meeting of the Students' Council and the Students' Executive Union.

S. 174 K. The Secretary of the Students' Council shall record and maintain the minutes of the meeting of the Council and of the Students' Executive Union.

**S. 174 L.** The minutes of the meeting of the Students' Council and the Students' Executive Union, shall ordinarily be placed for the confirmation of the Council or the Union, as the case may be, at their immediate next meeting.



**S. 174 N.** For the purpose of Clauses (i) and (iii) of Section 34(5) of the Act, the following shall be the Students' Societies/Associations/Organisations functioning under the aegis of the Students' Council :-

- 3. Dramatics Society, and

#### **COMMUNITY WORK**


