## **REPORT ON WASTE MANAGEMENT AT THE CAMPUS**

The institution has a centralized, transparent and well-planned waste management system. The institution has predetermined systems for managing different types of waste.

### Solid Waste Management -

Solid waste is generated mainly from three sources from the college: examination, library and canteen.

The paper waste generated from examinations and the library is disposed of through the Paper waste vendor. These paper vendors sell it to the agencies which manage the process of recycling.

Metal scrap generated is sold to metal casting companies through scrap dealers.

Decomposable and non-decomposable wastes are segregated in the canteen.

**The wet waste is filled in composters** and non-degradable waste is disposed of by BMC (BrihanMumbai Municipal Corporation) collection system.

### Liquid waste management -

The wastewater is disposed of as per BMC guidelines through the drainage system if it is contaminated with detergents.

### Biomedical waste management -

The institution does not actually generate any bio-medical waste during its operations. However, there are two probable sources identified which may generate bio-medical waste. (i) **Medical Centre:** The medical centre does not conduct any surgery or use syringes for injections. For any such accidents or ailments, the students are sent to the nearby hospital. However, for disposing of blood-soaked bandages the centre uses a red carry bag as per the guideline of BMC.

(ii) **Ladies Washrooms:** The used sanitary napkins are disposed of using black carry bags as per BMC guidelines. Female students and staff were educated to dispose of the used napkins using signage inside all ladies washrooms.

**E-waste management** – The institution organizes activities on environment protection, Go Green and other activities based on e-waste management. The institution provides assistance in the recycling of e-waste.

The institution conducts 3 types of activities with the old electronic durables:

- 1. DONATION The institution has been donating old electronic products which are in working condition to the needy people in the community.
- 2. DISPOSAL OF E-SCRAP: The e-waste which cannot be used in the above two categories is sold as scrap.

This activity of e-waste disposal is carried out once every 4-5 years so that a significant amount of e-products can be donated or disposed of. The vendor which was selected for the last e-waste disposal is a prominent e-waste management company in the city.

### • Waste recycling system -

- The Institution has a Gobble Bin for wet waste.
- For paper waste and metallic waste, the institution sells the scrap to agencies that either on their own or through another vendor get it recycled.
- For e-waste, the institution is either donating it for reuse or selling it to an agency which is an expert in e-waste management.

• Hazardous chemicals and radioactive waste management - No such waste is generated by the college.

#### THE POLICY:

#### 1. E-Waste Management -

An e-waste collection drop box for collecting small-size electronic waste has been kept in the main corridor of the college entrance gate. Students and staff deposit used e-waste into it. Institute takes the help of agencies for proper disposal of E-waste.

#### 2. Hazardous Waste -

The college does not offer any courses using chemicals and compounds with high-intensity of risk and side effects. In the college canteen, we use cups and stainless-steel plates for tea and snacks respectively due to these reasons plastics and paper cups are avoided.

Cigarette smoking is strictly banned on college campuses.

#### 3. Solid Waste Management -

The administrative supervisor ensures that the waste on each floor is collected at designated time intervals of the waste generated by all sorts of routine activities that include paper, plastics, glass, metals, foods, etc. Separate dustbins are provided on the campus for dry waste and wet waste. Housekeeping staff employed by the institution collect the waste from different locations, segregate it systematically into degradable, non-degradable, and finally dispose of it to the Municipality.



# 4. Wet Waste Management -

For wet and liquid waste management the various liquid wastes generated from the canteen and washrooms are drained to the Sewage system. A proper drainage system is arranged for the institution building. The institution has placed a Gobble Bin where the wet waste is collected and eventually converted into compost.

# Thus, the institution believes in Recycle & Re-Use practices by following the practices:

- 1. Segregate dry and wet waste for easy disposal.
- 2. Segregate plastic waste that can be recycled.
- 3. IT waste to be collected and sent for recycling. Proper record of IT equipment scrapped to be maintained.
- Waste from food products and the canteen is to be deposited into the compost pit / Gobble Bin.






